Mesquite Branch-

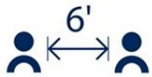
The Mesquite branch is open.

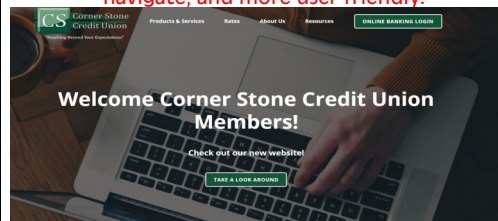
